HMK® S235 - STONE SEALER - matte finish

- **Protection and maintenance sealer for all rough and absorbent natural and artificial stone surfaces.**
 - **Reduces the penetration of water and dirt.**
 - **The color and structure of the surface will be enriched.**
 - **For interior use only.**

HMK® S235 is a ready to use color enhancing surface sealant with a matte finish that reduces the penetration of water and dirt substances into honed, brushed, sandblasted, flamed or riven natural stone (soft and hard stones), agglomerates and terrazzo. The color and structure of the surface will be enriched, leaving a matte finish. Facilitates regular cleaning and overall maintenance, especially on rough and textured surfaces. For interior use only.

Note: HMK® S235 should not be used in wet areas and will not be effective on most floors and polished and very fine honed stones, glazed ceramic/porcelain and non-absorbing surfaces.

Important: Once applied protect surface from rain and humidity for 12 hours. Do not apply to rubber, plastics, varnished surfaces and solvent intolerant surfaces. Remove all foodstuffs from the treated areas before work is commenced.

Instructions: Clean wall surface thoroughly and let it dry (max residual moisture of 2-4%). Apply HMK® S235 generously and evenly with a soft brush, HMK® Z950-Z951 Application Brushes or a roller with short fibres. If color has not been enhanced sufficiently, repeat treatment after 12 hours.

Once dry the residual material is not hazardous to health and is approved for use with foodstuffs by the LFGB (German Food and Feed Code).

To clean surface thoroughly before treatment use HMK® R155 Intensive Cleaner - acid free.

For regular cleaning and continued protection use HMK® P324 Liquid Stone Soap, a no-rinse natural product.

Coverage: About 5-10m²/litre.

Warning: Chemical product. Contains naphtha. Flammable. Keep away from heat, sparks and flame. Harmful or fatal if swallowed or inhaled. Ensure the area to be treated is adequately ventilated. Avoid eye/skin contact. If exposed wash/flush with water and seek medical attention immediately. Keep out of the reach of children. See Material Safety Data Sheet for more detailed information.

Packaging: 12 x 1 litre bottles/box; 2 x 5 litre cans/box; 2 x 10 litre cans/box..

Storage: Store in a cool place and keep lid tightly closed.

Testing: Always test the product in an inconspicuous area to evaluate suitability, coverage and performance. Do not use the product in temperatures below 12° and above 25°C.
